

MINUTES OF THE CITY COUNCIL, VICTOR, IOWA, MARCH 11, 2010

The city council met in regular session at city hall at 7:00 P.M. Present were council members Cavin, Robinson, DeNeve, Weiermann, and Faga. Mayor Roger Pawlak was absent. Mayor pro tem Faga called the meeting to order.

The council held a public hearing on the proposed 2010-2011 city budget with a proposed tax rate of \$9.48 per \$1,000 taxable valuation. The city council has kept the tax rate the same for many years. There were no comments from the public. Motion DeNeve, second Cavin to close the public hearing. Aye: Cavin, Robinson, Deneve, Weiermann, Faga. Nay: none. Motion carried. Motion DeNeve, second Robinson to adopt the 2010-2011 budget as proposed. Aye: Cavin, Robinson, Deneve, Weiermann, Faga. Nay: none. Motion carried.

Gary Edwards from the board of the East Central Iowa Council On Governments explained the Local Housing Trust Fund Program and the proposed resolution to recognize the East Central Iowa Housing Trust Fund. Four counties will manage the Fund -- Iowa, Benton, Jones, Washington. There is state money available for housing rehabilitation projects. Local money match will be determined later. The city can opt out of the program later at the city's option. Motion Robinson, second DeNeve to approve the resolution in support of the program. Aye: Cavin, Robinson, Deneve, Weiermann, Faga. Nay: none. Motion carried.

Motion DeNeve, second Cavin to approve renewal of liquor licenses for Stop 'n Sip and American Legion. Aye: Cavin, Robinson, Deneve, Weiermann, Faga. Nay: none. Motion carried.

Motion Robinson, second DeNeve, to approve the minutes from February 18 and the investment report for February. Aye: Robinson, Cavin, Faga, DeNeve, Weiermann. Nay: none. Motion carried.
